Increase from \$800 to \$1,000 per person.	Average tax savings per return:		\$23

<b>Standard Deduction</b>			
Single: Increase from \$3,000 to \$4,000.	Percent of single filers claiming the standard deduction:		86%

Neither are provisions affecting intangible holding companies, sales throwback, pass-through entities, streamlined sales tax statute, and county authority to levy cigarette taxes.
