<b>Personal Exemption</b>			
Increase from \$800 to \$1,000 per person.	Average tax savings per return:		\$29
	Average tax savings for a family of four:		\$47
<b>Standard Deduction</b>			
Single: Increase from \$3,000 to \$4,000.	Percent of single filers claiming the standard deduction:		75%
Married: Increase from \$5,000 to \$8,000.	Percent of married filers claiming the standard deduction:		25%
	Average tax savings per return: (Married filers would receive a greater benefit. Single filers would receive less.)		\$91
<b>Filing Threshold</b>			
Single: Increase from \$5,000 to \$7,000.	Number of filers no longer required to file a return:		272

<b>Age Deduction</b>

<b>Car Tax Reimbursement</b>

<b>Accelerated Sales Tax</b>

Note: Tax relief from the Military Family Tax Relief Act, and tax incentives for businesses to invest in equipment are not included in this table. Neither are provisions affecting intangible holding companies, sales throwback, pass-through entities, streamlined sales tax statute, and county authority to levy cigarette taxes.
