1121	Salaries, Administrative or Professional Faculty Higher Education	The title and definition are being updated to include "professional faculty." The title is also being updated to include the word "faculty", to be consistent with the existing subobject definition.
1126	Salaries, Teaching and Research Faculty	The title and definition are being updated to include the word "faculty" to be consistent with the phrasing use in subobject 1121.

1122	Salaries, Appointed Officials	The definition is being updated to formalize a long- standing practice of salary expenses for judges and justices being recorded under this subobject.
1124	Salarina Other Officiale	The definition is being updated to clarify that salaries for university staff who do not carry a faculty designation should be recorded using this subobject code. Under the existing subobject definition, employees who are exempt from the Virginia Personnel Act and whose salaries are not specified in Part 4 of the Appropriation Act should be recorded using this subobject code. University staff that do not have a faculty designation are not subject to the Virginia Personnel Act and therefore should be recorded using this subobject. Additionally, the definition is being updated to formalize a long-standing practice of salary expenses for Virginia State Police Troopers being
